- 4. Letter from Social Security stating gross monthly social security benefits (retirement; SSI; SSDI) and the date the benefits began for applicant (and spouse, if applicable). You can obtain this information by calling social security at (800) 772-1213 and requesting same be mailed to you at home or, you can go to a local office and it will be printed while you are there. You can go on the internet at www.ssa.gov and creat an account in order to be able to print out Social Security notices.
- 5. Letter from the Department of Children & Families (DCF) stating the type of public assistance you are currently receiving (Medicaid; Food Stamps). Medicaid card if you are currently a recipient of Medicaid benefits. You can go on the internet at www.myflorida.com/accessflorida and create an account in order to be able to print out Medicaid notices.
- 6. Written proof that the child has been determined to be disabled by the Social Security Administration.

- 7. Letters of Guardianship. Name, address, telephone number of the guardian's attorney.
- 8. Proposed Closing Statement (or settlement offer) for personal injury settlement.
